Inquisiq R3™ is a simple to use but powerful learning management system (LMS) that gives you the ability to deliver SCORM-compliant content in both public and private environments. It is a straightforward, robust solution with an intuitive interface that allows you to organize catalogs, review reports, issue certificates and sell your content using a variety of e-commerce solutions.

Inquisiq R3™ is offered in both **Software as a Service** (SaaS) and **Installed** (perpetual license) solutions to best meet your particular needs.

Software as a Service

The Inquisiq R3™ SaaS solution allows you to completely outsource your LMS application to ICS Learning Group. It is a pay-as-you-go all inclusive solution based on the number of unique user accounts in the system each month. A \$200 setup fee is all that is required to get your account up and running with no long term commitments.

Pricing includes the ability to make an unlimited number of branded Inquisiq R3™ LMSs under one account, although there is a \$200 one-time setup fee per LMS. Having multiple LMSs allows you to uniquely accommodate different clients and situations. Each LMS includes all administrative rights and privileges.

Pricing also includes web hosting of your LMS and phone and email technical support from 9 AM to 5 PM EST Monday through Friday (except holidays). This support is restricted to a designated set of your technical support staff and does not include end-user support. With the hosted solution you also get the benefit of receiving all Inquisiq software upgrades automatically at no extra charge.

Installed Solution

An Inquisiq R3™ unlimited user perpetual license can also be purchased for installation on your server, or you may have your license installed on a leased server from ICS (see page #4 for server lease details). This option may be more economical than the SaaS solution, especially when considering longer time periods and larger user populations. It also provides a solution when the application must run behind a firewall or in a more controlled network environment.

The Inquisiq R3™ application comes with the capability of hosting multiple LMS accounts – each one independent, with its own branding, user populations, courses and catalogs. Once Inquisiq R3™ is installed you will have access to the system control panel where you can create the separate LMS accounts.

Inquisiq R3™ Single-Server Perpetual License (one-time fee) - \$9950

Included with the Inquisiq R3™ license is the provision to create the following seven (7) LMS accounts:

- 1 - **Unrestricted LMS Account**, – a uniquely branded LMS with full capability and administrative rights, and no limit on the number of user accounts.
- 1 - **Developer LMS Account**, - with full capability and administrative rights, but whose use is limited to testing and development purposes only.
- 5 - **Content Reseller LMS Account**, - five LMS accounts, each one uniquely branded, with their own user populations and courses. These accounts have all the capabilities and features of the Unrestricted LMS account; however the courses can only be loaded by the Master Admin (you). These accounts are designed to provide you a means of distributing or reselling your courses using a uniquely branded and configured LMS. You can give others partial administrative capabilities including user management and reporting. Your customers will not be able to upload their own courseware in this account.

Additional LMS Account Licenses

Should your needs change, you can purchase additional perpetual LMS account licenses anytime (must be in the same installation) at the following rates:

1. **Unrestricted LMS Account** – \$2000 each
2. **Developer LMS Account** - \$450 each
3. **Content Reseller LMS Account** - \$250 each

Technical Support and Software Maintenance

We also offer an optional, but highly recommended technical support and software maintenance plan. The technical support plan offers you email and phone support between the hours of 9:00am and 5:00pm EST Mondays through Friday (except for holidays). It also gives you 24x7 access to our support site which includes a knowledgebase, articles, and a support ticket system. The software maintenance plan will give you access to all software updates and new versions as they become available.
